### **Introduction to ISSB**

On 26 June 2023, the International Sustainability Standards Board (ISSB) issued IFRS S1 *General Requirements for Disclosure of Sustainability-related Financial Information* and IFRS S2 *Climate-related Disclosures*. These standards will transform the global ESG reporting landscape, with corporate activity set to be highly scrutinised under these new sustainability reporting standards.

In Singapore, the Sustainability Reporting Advisory Committee (SRAC) has made recommendations for climate-related disclosures. This is now open for public consultation by SGX RegCo & ACRA till 30 September 2023.
