EDGE is free software, a green building standard, and an international green building certification system. More than 60 million m2 of floor space has been EDGE certified globally. Under his leadership, IFC has created a green building investment portfolio of commercial and residential buildings that totals more than US\$8.6 billion, both directly and through financial intermediaries.

Prashant is currently leading the <u>APEX Green Cities Program</u> that supports cities to transition to low-carbon and resource-efficient growth pathways. As a part of the Program, he has developed the APEX online app that allows cities to map out different action plans and evaluate their impact and financing options that the City can adopt to achieve its climate action goals.
